Dr. Nelda Mier is an Instructional Associate Professor with the Health Promotion and Community Health Sciences Department, TAMU School of Public Health. She holds a Doctorate in Health Education and two Master's degrees in the fields of communication and business. Dr. Mier has been teaching graduate and undergraduate courses in public health and communication for about two decades at prestigious universities in the United States and Mexico. Currently, she teaches courses in social dynamics of health, health promotion, data management, principles of program health management, and program evaluation. Students in her classes learn public health concepts, practical applications, problem solving, and critical thinking. Her high-impact instructional methods include collaborative work, project-based learning, field-based experiential learning, culminating experiences, and development of professional portfolios.

Dr. Mier also has extensive experience in community participatory research. Her work has addressed behavioral health among underserved populations living in the U.S.-Mexico border and Mexico. By applying ecological and culturally sensitive approaches in the design and implementation of health programs, Dr. Mier has made significant scientific contributions in chronic disease prevention and behavioral changes among Hispanic. She has published numerous peer-review articles in international and national journals, and has been a presenter at international, national, and regional conferences. Additionally, she has held leadership positions in academic, community and mass media settings.
